TOWN OF KYLE ANNIVERSARY CELEBRATION

Mark **June 15, 2019** on your calendars and watch for posters and information. Jan 1, 2019 marks the 60th Anniversary of Kyle as a Town (not to be confused with the 96th year as a hamlet/community)...whatever... it is still a great reason to celebrate. BYLAW INFORMATION

See the second page of this newsletter for excerpts on the Traffic Bylaw and the current Waste Collection bylaw. We have been receiving complaints in the office in regards to noted infractions of both these bylaws, so please read the information and we would be happy to supply anyone with the complete version on request.

TRAFFIC BYLAW

This is a reminder about on street parking of vehicles. Non-licensed vehicles are not to be parked on the street/boulevard. Please also note the time limit for parking on the streets. The full bylaw may be requested in print from the Town office or it can be viewed on the website : kyle.ca

10. Parking Prohibited:

- c) No driver of a vehicle whether making deliveries from the vehicle or not, obstruct the free passage of traffic on any street, lane or sidewalk.
- (f) No person shall stand or park a vehicle on any street, boulevard or any other town owned property unless it displays license plates for the current year or a valid permit in lieu thereof.
- (h) No person shall stand or double park a vehicle upon any street in town.
- i) (1) No person shall leave a licensed trailer on a public boulevard or any other town owned property which is unattached from the vehicle used for moving same;

Machinery and Equipment Parking:

- j) No parking of farm machinery, farm implements or contractor and construction equipment shall be allowed on any street except the north side of Railway Avenue between Sixth Street West to Second Street East, and then parking shall be allowed between the hours of 7:00 a.m. and 7:00 p.m.
- (k) **Time limit parking:**
 - ii) No vehicle shall be parked on any street, or lane for a continuous period of time in excess of 96 hours.
 - iii) Clause 10 (k) (i) shall only be enforced when the vehicle is creating a nuisance or hindrance.

SECTION X11 PENALTIES

- 42) A person who contravenes any provision of this bylaw or neglects or refuses to comply therewith shall be guilty of an offence and liable upon summary conviction to a fine of not less than \$100.00 and not more than \$2,000.00.

WASTE COLLECTION BYLAW

This is a reminder for residents about our current waste collection bylaw. The full bylaw can be requested in print from the Town office or can be viewed on the website kyle.ca

5. REGULATIONS FOR COLLECTION OF WASTE, COMPOST, AND RECYCLABLE MATERIALS.

c. Waste containers must be closed and no items placed on and/or outside of the container.

DO NOT: fill bags or container more than 40 lbs

- pile waste on the ground beside the garbage stand
- exceed the weekly per residential property limit of 4 large bags equivalent to 77 l container per household (excess bags may be taken by the property owner to the waste collection (landfill) site.

7. REGULATIONS FOR CONSTRUCTION MATERIALS

a) Any owner or contractor carrying out the construction, alteration or demolition of a building structure or landscaping on any property shall:

- not put construction material such as but not limited to: gyproc, insulation and large quantities of lumber in with domestic waste.

14. PENALTY

Any person who contravened a provision of Bylaw 05-2017 is guilty of an offense and liable on summary conviction to a penalty

- First Offence (\$100.00)
- Second Offence (\$200.00)
- Third or subsequent offence of not less than (\$500.00) and not more than (\$10,000) in the case of an individual or (\$25,000) in the case of a corporation.
