



BYLAW NO. 12-97

A Bylaw to Restrict Smoking in Designated Municipal Buildings

The Council of the Town of Kyle, in the Province of Saskatchewan, in open meeting enacts as follows:

1. In this Bylaw:
 - (a) "No-Smoking Sign" means any symbol or words or combination thereof as provided for in Section 4.
 - (b) "Smoke or Smoking" means and includes the carrying of any lit cigar, cigarette, pipe or other smoking device, or smoking of any cigar, cigarette, pipe or other smoking device.
 - (c) "Sports Centre" means the Kyle Community Sports Centre located at 224 Third Street West on a portion of LSD 15 of Section 32, Township 21, Range 15, West of the Third in the townsite of Kyle.
 - (d) "Town" means the Town of Kyle.
 - (e) "Town Administrator" means the Town Administrator of the Town of Kyle.
2. No person shall smoke anywhere in the Sports Centre, with the exception of the mezzanine area located on the upper level, during that portion of the year beginning November 1st and ending April 30th.
3. The Town Administrator is hereby authorized to post such signs as may be deemed necessary so that courtesy information may be provided to members of the public with respect to the provisions of this bylaw.
4. The signs referred to in this bylaw shall consist of graphic symbols or words that comply with the following provisions or combination thereof:

Issuing Officer

You may make voluntary payment of the above penalty at the Municipal Office of the Town of Kyle during regular office hours or by mail within seven (7) days from the date of service of this Notice of Violation.

If you do not make a voluntary payment within the time set out above, you shall be liable to prosecution and, upon summary conviction, you shall be liable to the penalty provided under Section 7 of the said bylaw.

5. Notwithstanding that the symbol in Section 4 is a cigarette, it shall include a lighted cigar, cigarette, pipe or any other lighted smoking device.
6. Any person who contravenes any of the provisions of this bylaw is guilty of an offence and on summary conviction, is liable to a fine of \$50.00 for the first offence, \$75.00 for the second offence and \$100.00 for the third and each subsequent offence.
7. Where a person has committed or is alleged to have committed a breach of any of the provisions of this bylaw, a ticket, as described in Form "A" attached to and forming a part of this bylaw, may be served upon the person requiring such person to pay to the Town the sum as prescribed in Section 6 above. Failure to pay the sum within seven (7) days of the issuance of the ticket may result in liability for prosecution.
8. A decision of the Court that one or more of the provisions of this bylaw are invalid in whole or in part does not affect the validity, effectiveness or enforceability of the other provisions or parts thereof with respect to this bylaw.
9. This bylaw shall come into effect on November 1, 1997.
