Projects for 2023

The Town Council would like to hear from you! The past few years the Town has been focusing on Asset Management for our critical services such as water and sewer and working towards road repair which we are continuing to work on. When the Official Community plan was being developed the community was asked for input on what you would like to see to beautify our community and what services you would like offered. We would like to start working towards those goals. There was a lot of want for Recreational development; to follow through on these suggestions, here are a few ideas we would like you to consider and let us know what you think!

1. Dog Park – The idea is to begin the first phase to develop an area for an exercise space for our four legged residents. The expectation for resources would be, after initial development, a small board would be responsible and any additions and future development would be fundraised and taken care of by this group.
2. Gazebo/Market Square space on Main Street- The idea is to start developing the previous Kyle Hotel lot into a useable space for outdoor entertainment in town.

Snow on Sidewalks

Thank you for keeping the sidewalks clear of snow in front of your houses and business! 😊 **Friendly reminder: Please do not move snow onto the Town streets from your property.** After the dry summer, this winter's snow will be a nice addition of moisture for your lawn, shrubs and trees.

Tax Payment Early Discount

Early payment of your property taxes comes along with a 3% discount. This discount is only available in January of each year. If you want to pay early, please have your payment into the Town Office before January 31st 2023.

2023 Business License

Business licenses are now due for 2023. A business license is required for:

“all persons carrying on any of the business, industries, callings or occupations defined in this bylaw who are not already assessed on the tax roll of the Town for such trade, occupation or business. Or those persons due to the nature of their business are required to be licensed.” If you do not pay a commercial property tax for a business that operates in the Town of Kyle, you are required to have a business license. This includes all door to door salespeople, home based businesses and street vendors.

A copy of the bylaw as well as the application and fee schedule are available at the town office. All businesses with a current business license will be listed in the business directory on the town website. Please include a business card for your business with your license so we can add you!

Single Person business- \$50.00
2 or more person ran business- \$100.00

Bylaw 01-2013- The Animal Control Bylaw

Under Section 4.

RUNNING AT LARGE

- a. The owner of a dog shall not at any time allow the dog to run at large within the town;

- b. The owner of a cat shall not allow the cat to run at large within the town without a tag
